Trip to Ufton Court

As part of their enrichment activities Year 4 will be going to Ufton Court in Reading on **Tuesday 24th March 2026**.

- We will be travelling to Ufton Court by coach.
- Children should wear their school uniform.
- We will be leaving school at 9:00am and returning to school by 3:30pm.
- Children will need to bring a packed lunch on the day which can be sent from home, or if you would like to order a School Meal packed lunch, please indicate this on the reply slip and return it to the school office by **midday Friday 30th January**. No orders can be taken after this date.
- Your child will require a water bottle.
- Please send lunch in plastic bags, so that we can throw any rubbish away rather than carry it around.
- Please ensure that your child is appropriately dressed for the weather.

As with all school trips, we ask for a voluntary contribution towards the cost, which will be **£22.10** per child, and which should be paid via your ParentPay account. If we do not receive enough contributions to the cost, unfortunately the trip will not be able to run.

Optional payment plan:

One lump sum - £22.10 by Friday 6th February 2026

or

Two payments - £12.10 First payment: due by Friday 6th February 2026 and the 2nd payment of £10.00 due by Friday 6th March 2026.

If you experience any difficulties accessing your ParentPay account please contact the school office. If you are unable to make the online payment with ParentPay, please request a bar-coded letter from the school office. Unfortunately, if your child is unable to attend the trip on the day, the school cannot refund the cost of the trip since the bookings have to be made and paid in advance.

If you have any trouble in making these payments, please contact the school office to arrange a meeting with a member of our Senior Leadership Team.

Please ensure that the permission slip is fully completed and returned to the school office by midday Friday 30th January 2026.
